

Safety Recall Campaign – FUEL PUMP REPLACEMENT- VGG05 Models: IS (ASE30/AVE30/GSE31), ES (AXZH10), GS (ARL10/GRL10/11 & GWL10), RX (AGL20/GGL2#/GYL2#), LC (GWZ100/URZ100), LS (USF40/GVF50/VXFA50/UVF4#), LX (URJ201), NX (AGZ1#), RC (ASC10/GSC10) & IS-F (USE20)

Published: 24 May 2021 - Operation Code: VGG05

BACKGROUND

Lexus has determined that a requirement exists for the initiation of a Safety Related Recall Campaign to be conducted in accordance with the FCAI code of practice for safety related recall campaigns affecting a range of IS (ASE30/AVE30/GSE31), ES (AXZH10), GS (ARL10/GRL10/11 & GWL10), RX (AGL20/GGL2#/GYL2#), LC (GWZ100/URZ100), LS (USF40/GVF50/VXFA50 /UVF4#), LX (URJ201), NX (AGZ1#), RC (ASC10/GSC10) & IS-F (USE20) vehicles sold in Australia.

DESCRIPTION OF PROBLEM

The subject vehicles are equipped with a fuel pump which may stop operating. If this were to occur, warning lights and messages may display on the instrument panel, and the engine may not run smoothly. This can result in a vehicle stall, and the vehicle may be unable to be restarted. If a vehicle stall occurs while driving at higher speeds, this could increase the risk of a crash.

TIMING / OWNER NOTIFICATION

Initial Recall

Interim notification letters were mailed to customers in April, 2020

Recall notification letters were mailed to Critical Fleet Guests in June, 2020

Further notification will be issued by mail and / or other means (SMS/email) to impacted vehicle owners progressively when sufficient parts stock is available requesting the owners to make an appointment at their preferred Lexus Dealer for rectification. Rectification will be conducted free of charge.

October 2020 Expansion

Interim notification letters were mailed to customers late November, 2020

Further notification will be issued by mail and / or other means (SMS/email) to impacted vehicle owners progressively when sufficient parts stock is available requesting the owners to make an appointment at their preferred Lexus Dealer for rectification. Rectification will be conducted free of charge.

Lexus is sending this letter to advise you that a Safety Related Recall Campaign involving your Lexus < Model> was announced in 2020.

You may have received an interim notification regarding this Safety Recall advising the replacement parts will be available progressively from early 2021. Lexus Australia is now in a position to commence rectification for this Recall on your Lexus <Model> and urge you to contact your nearest or preferred Lexus Dealer as per the instructions below to have your vehicle repaired FREE OF CHARGE. What is the Issue?

Your vehicle is equipped with a fuel pump which may stop operating due to a manufacturing concern. If the pump stops operating the warning lights and messages may display on the instrument panel and the engine not run smoothly. This can result in a vehicle stall, and the vehicle may not be able to be restarted. A loss of power while driving could increase the risk of a crash, increasing the risk of injury to the vehicle occupants and road users. In the event of a serious accident this may result in death.

What should you do?

Please immediately contact your preferred Lexus Dealer to schedule an appointment to have the Fuel Pump replaced **FREE OF CHARGE**. Please quote campaign reference number **VGG05** to your Lexus Dealer at time of booking. To assist your Lexus Dealer please present your vehicle with minimal fuel at the scheduled appointment, otherwise it may delay the repair time required to conduct the rectification. The recommended amount of fuel in your tank at the time of your appointment is <u>no more than a 1/4 tank of fuel</u>. Please refer to the gauge image indicating the recommended ✓ and non-recommended × amounts.
